Training in rules and regulations for lifting and hoisting

Person In Charge

Appointed Person

According to the European directive 2009/104/EC, in the Netherlands retrieved in the working conditions Decree (Arbobesluit) article 7.18 member 9, lifting and hoisting operations shall be carried out under proper supervision. Virtually any company that regularly has to deal with lifting and hoisting is familiar with procedures that must be followed. In compliance with the working conditions Decree someone who is responsible for the lifting and hoisting operations shall be appointed: the "Appointed Person". Within the international Oil & Gas industry also called "Person In Charge".

According to the same working conditions Decree, article 7.18 paragraph 8 it is a legal requirement that all actions for the lifting and hoisting shall be properly planned and carried out in such a way as to protect the safety of workers.

To be able to comply with these legal obligations, it is important that the "Appointed Person" has sufficient knowledge in the field of planning, management measures for safe execution, people, resources and circumstances.

12hoist4u organises courses that meet this required knowledge.

Target audience

The training is important for anyone who needs or should have knowledge about the specific rules and regulations related to lifting and hoisting due to his daily job activities.

To be more specific, think of: logistics coordinators, planners, lifting supervisors, work preparators, project managers, business leaders, prevention and HSE staff and coordinators, buyers of lifting and hoisting equipment, incidents investigators, constructors of work equipment, job owners, maintenance managers etc.

Content and program

The training has a structured set-up, where using a variety of very recognizable practice cases proceeds to the next learning objectives:

- Structure of the Dutch rules and regulation in relation to EU legislation
- > Planning and supervision of vertical transport in compliance with the legal provisions
- Lifting and hoisting equipment: legislation upon purchase, use and during maintenance
- Competence requirements of employees
- Working conditions Decree (Arbobesluit): work equipment and specific work.

In consultation, and if requested well in advance, your practice case can be evaluated.

Training material provided and Proof of participation

- Syllabus containing all training material and contents of the training
- 20 video's having the goal: "learning from incidents"
- The full text of Dutch HSE legislation the so called "Arbo Kwartet"
